Two parts to my answer here:

I was never a ski racer, but in 2015 answered the call for volunteers and since then I have served as a Ski Race Official. I've taken that job seriously. My Race History lists 85 Races, and I have studied to achieve 4 different certifications above the basic Competition Official, My plan is to continue to work races, and to always be learning

and growing in the roles. In the process I've learned the rules and mechanics of ski racing, how they are important for keeping races safe and fair, and the sheer number of people also willing to wake up early needed to make a race day successful. I will bring the knowledge and the relationships built to my role on the Board of Trustees.

But I will also call on the ski parent experience of being Ferryman, Fan, Consoler and Cheerleader. The experience of seeing my son emerge as a racer, and then as a young ski coach with more skill, confidence and of course speed than he had when he stepped on the snow at Hidden Valley in his first day, and those many days at Mountain Creek, make it clear to me that Ski Racing is Youth Development, and the support that our member clubs and their coaches and administrators need in their important work.

ASSOCIATION:

The role of secretary of NJSRA has also been a great way to observe the way our organization functions, and prepare for the responsibility of a voting role in the NJSRA. The job required me attend every meeting of the past two years, and to truly listen to what was being said, to gain an appreciation for the opinions and knowledge of the people on the Board of Trustees, and an understanding of the duty NJSRA has to its member programs, athletes and to the USSSA. I think it is one of the best ways to prepare for the responsibility of becoming a voting member of the Board of Trustees.
